We are delighted to present this beautiful 3-bedroom semi-detached house. The property opens into a welcoming hallway leading to the kitchen / fitted with ample storage, free standing oven and space for a washing machine.

In the event that consent is given for a pet to reside at the property an increased rent may be agreed between all parties.
