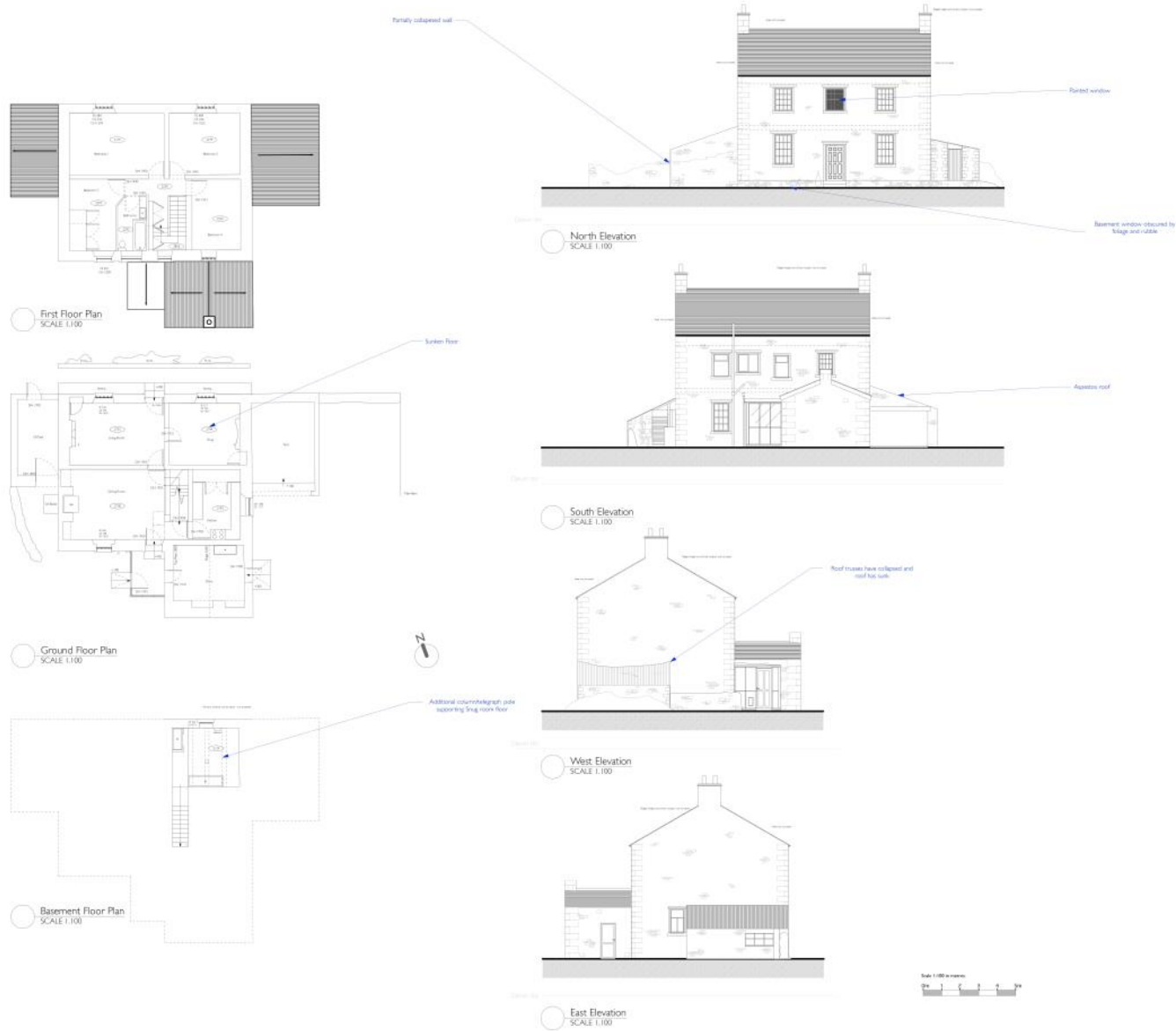

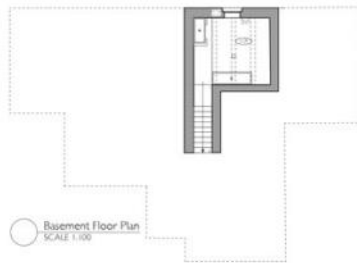

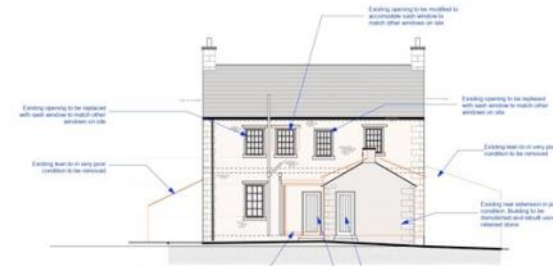
Basement Floor Plan

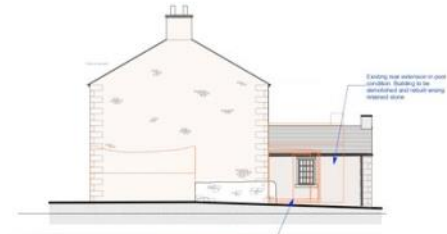
North Elevation

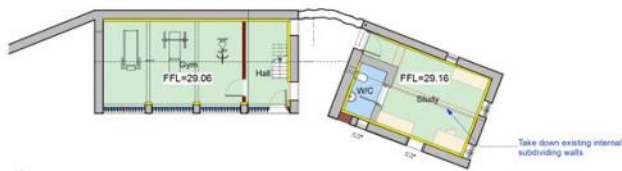

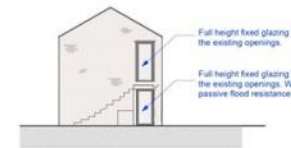

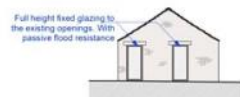
