This detached 2 bedroom true bungalow offers light and bright accommodation on a quiet residential street in the heart of Glasson Dock.

The front door opens into a small vestibule with further door into the inner hallway leading to all rooms in the property. The kitchen comprises wall and base units, 1 1/2 bowl sink unit, oven, hob and extractor over. There is space for an undercounter fridge. In the dining end of the kitchen there are cupboards with space for a washing machine and dishwasher. There is also a door to the rear patio. The lounge has an ornamental fireplace and bay window to the front. The shower room has a large corner shower, sink and toilet. There are two double bedrooms, one to the front and one to the rear.

Outside is a detached single garage with light and power. There is ample off road parking on the block paved driveway. To the front of the property is the lawned garden with shrub borders.

Rent and deposit: One completion of the application and offer of an Assured Shorthold Tenancy Agreement by the agent or Landlord, full payment of 5 weeks rent is required as a returnable rental deposit immediately along with the signing of Agreements. The deposit will be held within Armitstead Barnett LLP Clients Account. The deposit will be registered with My Deposits. The holding deposit of 1 weeks rent can be used as a contribution the first month's rent. The first month's rent will be required 5 working days prior to the start of the tenancy. In the event that consent is given for a pet to reside at the property an increased rent may be agreed between all parties. Where a tenant requires a guarantor, the guarantor will be required to complete the same application process as a tenant. The guarantor will also be required to sign the deed of guarantee agreement prior to the commencement date
